Thank you for your freedom of information request of 23 October 2024. We are responding to you under the Freedom of Information (Scotland) Act 2002.

### FOI REQUEST (23 October 2024)

- 1. The number and details of grants awarded by South of Scotland Enterprise (SOSE) for the installation of solar panels on business premises in the Borders and across Scotland, including:
  - o The total number of grants awarded
  - o The total value of grants distributed
  - o A breakdown by year and region (if available)
- 2. A detailed outline of the application process for businesses interested in applying for grants to install solar panels, including:
  - o Eligibility criteria
  - o Required documentation
  - o Timelines and assessment processes

#### CLARIFICATION (Received 24 October 2024)

Request: Clarification on what was meant by breakdown by year' and 'breakdown by region'.

Response: Breakdown, by calendar year from 2018 to October 2024, detailing the specific regions or areas within the South of Scotland (e.g., Ettrick, Roxburgh, and Berwickshire, or Dumfriesshire)? If obtaining this level of detail presents a challenge, a summary for the entire South of Scotland, broken down by calendar year from January 2018, would be sufficient.

#### **FOI RESPONSE**

South of Scotland Enterprise (SOSE) was launched on 1 April 2020, therefore we have provided information for the financial years from this date.

- 1. SOSE do not have specific grants solely for the installation of solar panels. We have provided the following information for the south of Scotland region:
  - a) SOSE grant awards where the whole grant was for installation of solar panels TABLE A
  - SOSE grant awards where installation of solar panels was a <u>component</u> of the overall project TABLE
     B.

The solar panel component of the grant award can incorporate a range of costs including panels, batteries, ventilation, inverters and other electrical and installation work and can be a requirement of the building warrant rather than a specific measure installed as part of the funding award.

  - Economic case (including impact on Place, Inclusive Growth, Fair Work, Net Zero, Natural Capital, Community Wealth Building)
  - Financial case (including consideration of Value for Money, additionality, displacement)
  - Management case
  - Commercial case

The approval process follows our Delegated Authority Policy and successful approval is based on project alignment with strategic priorities, appraisal criteria (above) and available budget. A grant offer letter outlining the award terms and conditions is signed by the organisation and SOSE.
