Thank you for your freedom of information request of 7 November 2024. We are responding to you under the Freedom of Information (Scotland) Act 2002.

FOI REQUEST (7 November 2024)

Please provide the following information regarding your enterprise support public body:

- As of 1 April 2024, total number of employees headcount and whole-time equivalent.
- 2. As of 1 April 2024, a breakdown of employees by job title and number. This should involve three columns department, job title, and number of employees in that role. Please provide both headcount and WTE figures.
  - a. For each role name, please provide median and mean cost of individual staff members (i.e. salary + other employment costs like employer NI contributions), median and mean annual-whole-time-equivalent salary, and total cost of employing all the employees with that job title in that department.
- 3. Total staffing outturn for the 2023-24 financial year, and for the 2023 calendar year.
